### SPP Deed Restrictions Updates Proposed by Colette Robichau

The SPP Deed Restrictions Committee distributed its first publication of the proposed updates to the deed restrictions in the February *Pulse* and we are pleased with the feedback received thus far from our residents. The majority of the feedback forms were in favor of the proposed updates, but there was some confusion around the form wording. The committee has reviewed the comments and updated the information flyer clarifying the areas of concern.

We ask all residents to review the flyer insert and provide feedback comments as desired. The next planned step in this process is to hold at least two public meetings—a weekend meeting and a weekday evening meeting—for residents to discuss the proposed updates. The committee expects to hold the Public Comment Meetings during the month of April. Based on the public comments from these meetings, adjustments to the deed restriction updates may be made and the final legal document will be prepared. The legal document with the proposed updates will then be used for the Civic Club authorized signature gathering process which may take two or three months. At this time the committee expects to hold signature gathering meetings to make it easy for our residents to participate in this very important process. The meeting dates and times will be published in the *Pulse* when the schedule is confirmed.

## **Gardening Tips from the Pros—The Garden Club**

**Outdoor Tip of The Month:** Here is the dirt; for easier transplanting or planting flowers or shrubs, spray your shovel or trowel blade with cooking spray before you start digging. The soil will slide right off!!

**Indoor Healthy House Plants:** If you are not ready to move outside just yet, try feeding (all year long) your indoor palm or fern monthly with 2 tablespoons of pure vegetable oil. Use a small kitchen funnel pressed into the soil to carry the oil to the root of the plant.

#### Houston Crime Report by Chuck Blesener

HPD North Division Captain D. T. Runyan says that although there has been a recent rash of home and car burglaries, citywide property crimes, assaults, and murders are down. Property crimes are the lowest they have been since 1965.

In North Division alone COP volunteers patrolled 17,908 hours in 2010 and 13,500 hours through October of 2011. The volunteers of the SPP Citizen's Patrol contributed a large portion of those hours.

HPD has started enforcing the ordinance against vagrants and panhandlers at local intersections. While they have gone to the North Loop, Crosstimbers, Airline, and Hwy 290, their main emphasis has been on the North Fwy where they wrote 170 citations in one month. First amendment rights allow anyone, including charities, to solicit on our streets but there are ordinances that control their behavior. All panhandlers and solicitors must have a City permit even though it does not have to be visible. They must wear a visible/reflective vest and can't step into the roadway. They must remain on the curb or median and can't litter the area they are working. Most of our panhandlers have a criminal or drug history and/or mental problems, and the police encourage you to give your donations to charities that assist them and not to the panhandlers directly.

The law has been changed so that all freeway overpasses are now the property of TXDOT and signs have been posted prohibiting sleeping or living under bridges or overpasses.

In Texas you can't be homeless and a registered sex offender. You must have a physical address. Recently in a two day period they arrested ten homeless men on the North Freeway including five sex offenders and three pedophiles.

#### Facts Revisited for Heavy Trash by Chuck Blesener

SPPs date for heavy trash collection is the **fourth Tuesday** of every month. It is not the third Tuesday or fifth Tuesday or necessarily the last Tuesday since some months have five Tuesdays. The COH Solid Waste Department has decided that odd numbered months should be for tree waste so that this material can be recycled instead of depositing it in a landfill. Even numbered months are for junk waste such as furniture and appliances. That being said, if you call 311 they will tell you that you can put out tree waste on any month. If you put it out on the junk waste months, it will wind up in a landfill and that will waste taxpayer money. Try and follow the approved schedule.

## **What's Happening Around Houston**

#### The Rookery at Smith Oaks High Island, Texas

The island in the middle of Claybottom Pond at Smith Oaks has become a favorite roosting and nesting place for many water birds. In the spring and summer herons, cormorants, egrets, and spoonbills build their nests and raise their chicks on the predator free island. Visitors can get a close look at the home life of these beautiful birds throughout the breeding season. The most spectacular time of day to visit the rookery is the last hour before dark. The show at sunset is something not to miss. Thousands of birds spend the night on the island in Claybottom Pond. This show starts about an hour before sunset when the first birds trickle in. Soon it is small flocks, then big flocks pouring in from all directions. Nesting activity usually starts in March and by mid April is quite active. You can get a close look at the activity from the trail around the pond.

Claybottom Pond was included in the land Amoco donated to The Houston Audubon in 1994. When The Houston Audubon Society first acquired the pond, nothing was nesting there. This was probably due to

the fact that birds, turtles and alligators in the pond were often used for target practice. The "no hunting" policy resulted in quick changes and in July 1995, 50 heron nests were found on the island. By 1997, 332 pairs of birds nested on the island and the first pair of Roseate Spoonbills showed up. The number of pairs of birds grew to 1083 in 2003, and now it is quite a show.

**Hours**: The Rookery is open to the public sunrise to sunset.

**Location**: High Island is on the coast just off Hwy. 87. Take I-10 east from Houston, take the Winnie exit, then go south on Hwy. 124 to the town of High Island.

#### **Domestic Violence** by Chuck Blesener

Officer Janette Arceneaux of the North Division, Special Crimes Division, Domestic Violence Unit tells us that domestic violence can be physical, emotional, sexual, or mental. It is a learned behavior and not hereditary. While it is not caused by alcohol or drugs, it is enhanced by their use. All family violence should always be reported to the police even though most victims do not follow through with charges.

There are 36,000 reported cases of domestic violence each year in Houston with 50 of them resulting in murder. The category of new or old boyfriend or girlfriend has just been included and will probably add another 10,000 cases to those statistics. Although most victims are women, more men are reporting being a victim in the last five years. A shocking 30%



of women murdered are killed by their husband or boyfriend. Family violence is a large percentage of reported assaults with national statistics showing 20% of all high school girls having been assaulted and three women are killed each day. The average victim tries to leave their abuser 7-9 times before finally leaving.

Locally victims can go to the Houston Area Women's Center where they have an HISD school on site for children. To keep the abuser away, victims can get an emergency 61-day protective order, enforced by HPD and can be extended to two years. This is different from a restraining order which is a civil injunction enforced by the court. For the convenience of victims, there is an Assistant District Attorney and court officials available to write protective orders at the HPD North Division Headquarters, 9455 West Montgomery, on Mondays from 9am to 3pm. On their second assault, the abuser can be charged with a felony, even if it involves a different victim. The law was changed two years ago so that even if the victim refuses to file charges, the police can file felony habitual assault charges against someone if there has been as few as 2-3 reports a year of domestic violence.



The group is open to all men of the neighborhood and they would especially like to invite any newly retired men to join them.


