



NOTICE OF AT&T WORK IN THE AREA

AT&T is scheduled to begin work in the SPP area around 9/14/15, with a projected completion date of around 10/14/15. AT&T contractors may be trying to gain access to utility easements in SPP residents' yards, as they are launching **Giga Power** in the Houston market and SPP has been chosen to get it before anyone else. Once the project is complete, residents may get up to 1000 meg internet service! They will try to complete this work with minimal disruption.

If asked for access to their property, residents are encouraged to ask to see workers' badges.

Update on Feral Cat Population By: Catherine Powell

Hello neighbors. I am VERY happy to report that the feral colonies in SPP are almost finished with TNR (trap-neuter-release). I have compiled all of the results since March 2015, when I started all of this. I have been working with 2 colonies: 1)Brian Haven@Thornton and 2)Lehman

40 cats have been altered, vaccinated, and released (4 of these cats were pregnant). Approximately 6 cats were relocated to become barn cats. 44 kittens were rescued, fostered, and found homes. I have so many people to thank for their help in this process, including all of you who donated to the cause. My TNR work will never be finished, but it is nice to see the progress we have made.

"Annie" is a 12 week old female tabby kitten who was rescued from the Brian Haven colony. She has been in foster care for 6 weeks and remains a very shy and timid little girl. She is slowly gaining trust in the human species and will need a quiet home where she can explore and play. She loves other cats/kittens and is used to calm dogs. BEWARE OF SOLICITORS By: Chuck Blesener



We have recently seen a sharp increase in the number of solicitors going door to door in our neighborhood. We have gotten many complaints that they are rude, intrusive, accomplished liars, seeking money fraudulently, and showing up late into the evening. While our Deputies and HPD officers can't run them off, they can check them out and discourage them.

Councilmember Ellen Cohen's office tells us that some state laws were changed in a recent legislative session that required the City of Houston to rescind the ordinance regulating solicitors, and prevents HPD from enforcing 'No Soliciting' neighborhood signs. They are no longer required to register with the city, obtain permits, or wear picture identification. The police can still enforce 'No Trespassing' signs but they must be placed on the front of each individual home to be legal.

Many solicitors prey on seniors thinking them to be easy targets but all of us can become victims. While a few of them represent charities, politicians, or religions, most are scam artists seeking to separate you from your money. Signing a petition is their introduction to asking you for money; selling magazines that you will never receive is their way to steal your identity off your check information; hiring them to do jobs around your home is inviting them to steal from you or to come back and burglarize your house.

HPD and the Constable recommend you always respond to someone at your door so they won't try and break in with you in the house. You do not have to open the door to anyone you don't recognize. Just tell them you are not interested in whatever they are selling and to go away or you will call the police. If they say they are from a utility or company to do work in your home or yard, verify their identification, verify they are in a marked company vehicle, and call the company to verify they are supposed to be there. In any case, if they appear suspicious or refuse to leave, call Constable Dispatch at 713-755-7628 or HPD at 911. (For more on this, see the notice on page 2 of this Pulse about upcoming A T & T work in our area.)

It is advisable to not do business with anyone who comes to your door that you did not call or do not recognize. Do not give money to anyone, sign a petition for anything, hire anyone, or buy anything from someone who rings your doorbell. Research and investigate all charities and businesses before you give them money. Contact and deal with them personally by mail, telephone, or online.

RETRIEVING STOLEN PROPERTY By: Chuck Blesener

Our Deputies do a great job protecting us and our property but they need a little help from us. The first thing we can do is to report all crimes so they are aware of all the crimes that have happened. The other thing we should do is keep a current accurate list of our valuables - descriptions, pictures, serial numbers, model numbers, receipts, and owners manuals. Deputy James Moulden has recently solved two crimes and is working on a third where stolen items have been retrieved and returned to residents. He has obtained arrest warrants for those involved in selling the stolen items. Here is what Deputy Moulden has to say . "It would be awesome if all the people in the subdivision would keep up with their serial numbers on tools, electronic devices, guns and lawn equipment. With this simple thing it makes my job a whole lot easier to find, recover and file charges in these cases."

You can keep these records yourself or you can use a service called LeadsOnLine, the nations largest online investigation system to recover stolen property. It is a technology service helping law enforcement catch criminals while helping businesses reduce the hassles of reporting. Certain businesses, such as pawn shops, second hand dealers, gold buyers, scrap metal dealers, and Ebay listings, are required by law to report all transactions in used merchandise. This service is restricted for use by law enforcement and businesses only, but they have a service called ReportIt, which is a citizen property inventory system. You can securely store serial numbers, item descriptions, pictures, and scans of receipts for 100 items of valuable property free of charge that is accessible from anywhere at any time. Only you will have access to this password protected site where you can retrieve information for the police or insurance company in case of theft or loss.

Your prompt reply is also needed as our 2016 contract with Harris County for our Contract Deputy Patroller must be signed and executed in December.

Cook's Corner



PECAN PIE

1 cup light Karo Syrup 1 cup granulated white sugar 4 eggs, lightly beaten 1/2 stick butter, melted 1 tsp. vanilla extract 1 1/2 to 1 3/4 cups pecan halves (or quarters) Uncooked pie shell/crust (purchased or homemade)

Mix first 5 ingredients in a large bowl. Add the pecans. Mix lightly. Gently lay the uncooked pie crust in 9" regular pie plate and pour mixture into the pie plate. Bake at 400 degrees for 15 minutes. Reduce oven temperature to 300 degrees and cook pie for another 43-45 minutes. Do not overbake!

BUILDING PERMITS AND CODE ENFORCEMENT By: Chuck Blesener

There are always homes in our neighborhood that are being remodeled, repaired or changed in some way. Most of these residents get approval from the civic club, hire a reputable contractor, and obtain the necessary building permits from the city. Then there are always some who try and save some time and money by taking shortcuts. It is important that we enforce the deed restrictions and building codes to maintain our property values and the quality of life in our neighborhood. Any obvious lack of permits where construction is ongoing will be reported to the city for enforcement. If you observe contractors working on a home where no building permits are visibly posted, contact a civic club officer or go to the shepherdparkplaza.com website and click on the link to the Architectural Control Committee.

Building permits are required if you are in the corporate city limits of Houston and are doing projects which include construction work on new or existing buildings, remodeling, or building repair work. Most projects require a permit. Any alteration, repair, remodel, renovation, or new construction requires permits. All mechanical, electrical, and plumbing work must be permitted and performed by a licensed tradesman or contractor. Some exceptions to the requirement for permits include - painting, carpet/tile/wood flooring, interior trim and similar finish work, wood or metal fences up to eight feet tall, residential storage sheds less than 120 square feet, uncovered decks up to 30 inches above the ground. Roofing does require a permit.

Even where a permit is not required, residents and contractors are required to follow city building codes and neighborhood deed restrictions. When obtaining a permit, home owners will have to complete and sign an affidavit under penalty of perjury that is called "Declaration in Support of Application for City of Houston Building Permit". You will swear that you understand what a deed restriction is, that you understand that copies of the deed restrictions are available for your review, and that your project does not violate any of these deed restrictions. If any statement in your Declaration is false, the city may void any permits obtained, may order you to remove part or all of your project at your expense, and can prosecute you for perjury for lying on an official document.

The best way to avoid problems and speed up your application process is to submit your plans for any project to the Architectural Control Committee of the SPP Civic Club. After your plans are reviewed and approved, you will receive a letter that you can furnish with your application to the City. More on building permits and code enforcement next month.

Street sign down? Traffic light blinking? Tree limb down over the street? The City of Houston has a dedicated phone line for these types of non-emergency related issues. You can dial 3-1-1 from any land or cellular line or you can download the app to your SmartPhone.

Women's Safety Class Update

A group of ten very determined SPP female residents took a Self Defense class through a program provided by the Harris County Precinct 1 Constable's office. There were about 10 other participants, including some from the church that hosted the event and from the surrounding communities. The class was called RAD or Rape Aggression Defense. It was a 12-hour class packed with safety tips and hands-on self-defense techniques, with the last three hours being a simulation of the techniques learned over the previous three days. The simulation involved participants in heavy protective gear defending themselves against a simulated attack. The attackers/aggressors were Constable's office officers. Officer Tracie Mathews-Segura was the primary trainer and monitor of the participants' training and she was inspirational,

encouraging and supportive. It was evident that Tracie wanted everyone who attended to get the tools they needed to have the confidence to defend themselves. Each participants' abilities were considered and the training was adjusted to give them tools to defend themselves when attacked, including the Senior citizens that participated. It was evident that everyone's confidence grew as the week progressed. A huge thanks to St. Stephens United Methodist Church on 43rd for hosting the event, and a heartfelt thanks to Deputies Tracie, Shonnie, April, Jackie, Carlos and the others that provided the training. SCOUT TROOP 20 ADDS IMPROVEMENTS TO THE COMMUNITY GARDEN ON ALBA

Adam Capfer, along with members of Scout Troop 20, provided long-needed concrete borders for the garden beds at the Community Garden on Alba, between Sue Barnet and Chamboard. The garden is a joint project of Garden Oaks and Shepherd Park Plaza and was started by former Garden Oaks resident Jan Koenig. When Koenig moved from the area, Beth Galiano, Harris County Master Gardener, took over the duties of managing the garden. Galiano has managed the garden for more than twenty years. The garden supplies organically grown fresh vegetables to needy families, free of charge, through local food pantries. Ed and Brenda de Alba of Garden Oaks donate operating expenses for the garden.

Adam's project was completed in June as part of his earning his Eagle Scout Award. Troop 20 is sponsored by St. Matthews Methodist Church (4300 N. Shepherd Dr, -Crosstimbers/43rd).
